IV. INTERVIEW OF HANK M. BOUNDS, PH.D., FOR THE POSITION OF PRESIDENT OF THE UNIVERSITY OF NEBRASKA

Chairman Hawks welcomed University of Nebraska presidential finalist Dr. Hank M. Bounds and his wife, Susie, to Nebraska and noted that the couple spent the prior day meeting with students, faculty, staff and administrators at UNL and would visit the remaining NU campuses over the next two days. In addition, they will meet with other important constituencies of the university including donors, agricultural leaders, the media and the general public.

Chairman Hawks invited the members of Board of Regents to introduce themselves and then facilitated the Board's format interview of Dr. Bounds. Board members asked questions in about a dozen topic areas.
